A Letter from the President and Chief Executive Officer



Recent economic challenges and rising litigation have confirmed that now, more than ever, businesses need expert resources for managing complex disputes and containing costs. These practices are no longer alternatives to consider. They have become essential legal tools. So, as general counsel rejected the billable hour model and organizations called for fresh ideas to provide legal value, CPR invigorated and expanded its own activities, focusing on new ways to reduce the total cost of conflict with prevention as the cornerstone.

CPR's conferences, trainings, Web-based initiatives, and innovative programs continue to garner accolades and have expanded the community of ADR users and advocates. Recently, remarkable progress has been made to improve arbitration. CPR's new Protocol on Disclosure of Documents and Presentation of Witnesses in Commercial Arbitration is one of the most pioneering responses to the arbitration discovery issue in decades. In addition, CPR's new Early Case Assessment Protocol highlights the creative thinking of the CPR community by providing resources for evaluating cases in a systemic way, and at an early stage, before costs mount and resolution becomes more difficult.

CPR's Committees

CPR believes that the field of ADR can be advanced only by exploring and analyzing the latest developments in commercial conflict management and dispute avoidance processes within various business contexts. We invite our members, academics, and neutrals to join industryand practice-specific committees to study current challenges, make recommendations for best practices, and publish materials on issues at the forefront of legal debate. These Committees meet regularly to draft rules, books, studies, statements of best practices, and propose industry protocols for use by attorneys and business executives around the world. By engaging practitioners in meaningful collaboration, CPR leads the way in establishing ADR best practices across industries.

Arbitration Committee

CPR's largest Committee and its subcommittees met more than 20 times during 2008/09. The Subcommittee on Information Exchange delivered the *CPR Protocol on Disclosure of Documents and Presentation of Witnesses in Commercial Arbitration.* The Protocol gives parties options for the use of document discovery in arbitration and recommends the adoption of procedures that achieve a balance between the realities of modern electronic document retention policies and the goals of efficiency and cost containment in arbitration. The Subcommittee on Expedited Arbitration Rules drafted a set of global accelerated rules aimed at complex commercial disputes, which were delivered in late July 2009. The Subcommittee on International Neutrals continues its work on enhancing CPR's International Panel. The Chair of this Committee is Lawrence Newman of Baker & McKenzie LLP.

Banking and Financial Services Committee

The Banking and Financial Services Committee has met periodically since 2007 to consider the possibilities for using alternative dispute resolution methods to resolve anticipated disputes among financial institutions. This Committee has been less active in the past year, in light of recent industry challenges.

China Advisory Committee

This group of attorneys and business people located in the United States and China has met periodically to explore CPR's growing activities in connection with its relationship with the China Counsel on Promotion of International Trade and its joint project, the U.S.-China Business Mediation Center. In addition, the Committee assists CPR in developing initiatives of interest to CPR members doing business in China. Currently, CPR is exploring the expansion of this Committee to include ADR efforts throughout Asia. The Chair of this Committee is James Zimmerman of Squire, Sanders & Dempsey L.L.P.

Committee on Energy, Oil and Gas

The Committee on Energy, Oil and Gas was formed in 2000 to study current challenges to these related industries. It has assembled a blue-ribbon international panel of energy neutrals in sub-specialties ranging from alternative energy sources to nuclear specialties. In November 2008, Fulbright & Jaworski, L.L.P. hosted the Committee and other CPR members for a presentation on various arbitration bills pending in Congress and to discuss CPR's non-administered arbitration process. The Energy Committee also used the opportunity to review the applications of several candidates for CPR's Panels of Neutrals. The Chair of this Committee is Duncan MacKay of Northeast Utilities.

Construction Advisory Committee

This Committee, established in 2004, is assisting in broadening and enhancing CPR's Panel of Construction Neutrals and plans to create other tools of immediate practical use to the Construction Bar. Recently, its sub-committees produced three briefings: "Partnering: A Management Best Practice;" "Realistic Allocation of Risks: The First Step in Dispute Prevention;" and "Dispute Review Boards (DRB's): A Management Best Practice." It is expected that these briefings will be published in the coming year.

Corporate Insurance Coverage Initiative

The mission of this Committee, formed in early 2005, is to devise protocols for the early and just resolution of coverage disputes between insurers and corporate policyholders. The Committee crafted and disseminated its *Mediation Principles for Insurer-Insured Disputes* in 2006. In 2008, Committee members assisted CPR in drafting articles for industry publications and reviewed the applications of neutrals to the CPR Insurer/Policyholder roster of neutrals.

CPR's Committees, Commissions, and Task Forces are formed to study particular challenges within a specific industry or practice area.

Corporate Protocol Commission

The Corporate Protocol Commission was formed in 2006 and is primarily composed of corporate in-house counsel. The Committee discusses innovations and trends in corporate conflict management, the future of the corporate legal function, and general counsels' ever-changing relationships with outside counsel. Its purpose is to create and disseminate corporate-oriented products that will promote greater use of early dispute assessment and resolution processes. In 2009, in conjunction with the Early Case Resolution Committee, the Commission helped draft CPR's Early Case Assessment Guidelines.

Early Case Resolution Committee

Formed in 2007, this group explores cutting-edge techniques being employed by collaborative and cooperative lawyers to resolve selected civil disputes. The Committee has begun work on products to transfer and translate these techniques for the commercial sector. In 2008, the ECR Committee met jointly with the Corporate Protocol Commission to draft CPR's Early Case Assessment Guidelines to help businesses decide how to manage disputes. Future projects include the recruitment of a special CPR Panel of experienced settlement counsel. The Chair of this Committee is Professor John Lande of the University of Missouri Law School.

eDiscovery Committee

This Committee studies and advocates effective merging of technology, procedures, and discovery expectations to devise informed and efficient exchange of information in litigation, arbitration, and other contexts. The Committee and its subcommittees met numerous times in 2008/09. It conducted a training workshop for neutrals on the basics of eDiscovery and compiled a new panel of neutrals, expert in eDiscovery, who are available to assist parties as special masters or in resolving eDiscovery disputes out of court. The Co-Chairs of this Committee are Charles Morgan of FTI Consulting and Thomas Allman, Esq.

CPR's Committees comprise the industry elite – attorneys handling the most sophisticated commercial matters as counsel or neutrals, leading scholars and corporate counsel commanding the highest litigation dollars.

In late 2008, CPR formed a new committee focused on Health Care and Life Sciences to study trends and draft best practices and ADR tools to address, manage, and resolve disputes in the industry.

Employment Disputes Committee

This Committee includes over 100 corporate representatives, arbitrators, management lawyers, employee representatives, former judges, human resources professionals, mediators, and professors. In 2008, the Committee reviewed recent developments in the field, including discussions of CPR's policy to decline to administer employment arbitrations, and a roundtable on the perspective of claimants' counsel on current practices in arbitration and mediation. A presentation was also made on the case pending before the U.S. Supreme Court regarding the effect of mandatory arbitration clauses in collective bargaining agreements with regard to statutory discrimination claims, as well as seeking to amend the Federal Arbitration Act to exclude the arbitration of statutory employment and consumer claims. In 2009, the Committee considered new initiatives, such as CPR's resumption of administering employment arbitrations, updating publications, and investigating how CPR's resources can assist corporate clients and their employees in this difficult economy. The Chair of this Committee is Jay Waks of Kaye Scholer LLP.

European Advisory Committee

This group comprises representatives of CPR's European membership and is a forum for discussion and analysis of ADR developments on the Continent and guides CPR's strategy outside of the U.S. The European Advisory Committee met twice in Zurich and once in Paris during this fiscal year. These meetings focused on the impact of CPR's recent efforts in Europe and the importance of continuing its unique contribution to the development of sophisticated dispute management practices in the area. The Chair of this Committee is Hans Peter Frick of Nestlé S.A.

European Insurance Committee

This Committee met at the headquarters of Swiss Re in Zurich in late 2008. At that meeting, Lord Charles Falconer, former Lord Chancellor of England, shared his view on the necessity of efficient business dispute management. The group, comprising representatives from 16 countries, shared ideas on how inter-insurer claims – both at the primary and excess level and in reinsurance treaties – can better be managed. The Chair of this Committee is Albert Hilber of Swiss Re.

Franchise Mediation Program

CPR administers the Franchise Mediation Program, which is led by a steering committee of franchisors, franchisees, and other influential participants in the franchise community. The mission of the Program is to encourage the mediation or other non-judicial management of disputes arising between franchisors and franchisees. In 2008, the Committee refocused the Program's mission toward advocacy and education. Early in 2009, the Committee published *Managing Franchise Relationships Through Mediation*. This volume proposes and explains a fair, just, impartial, and expeditious way of resolving disputes within the franchise community. The Co-Chairs of the Program are William Hall, a Dairy Queen franchisee, and John Kujawa of McDonalds USA LLC.

Global Reinsurance Protocol Committee

In 2007, this Committee aggressively promoted the CPR *International Reinsurance Industry Dispute Resolution Protocol* through numerous speaking engagements, published articles, and marketing efforts. The Committee has been less active in the past year in response to recent industry challenges. The Chair of this Committee is Paul Moss of Montpelier Syndicate 5151.

Health Care and Life Sciences Committee

In late 2008, with the health care and life sciences industries poised for reform, CPR responded by forming this Committee. It comprises leading practitioners, corporate counsel and academics with experience in the resolution of disputes among healthcare and life sciences corporations, institutions and parties involving issues specifically related to these entities and the complex regulatory framework in which they operate. In the coming year, the Committee will study current challenges and trends in the industry and draft best practices and ADR tools to address, manage, and resolve disputes. Recently, the Committee created an industry-specific panel of neutrals expert in health care- and life science-related disputes. The Chair of this Committee is Katherine Benesch of Duane Morris LLP.

Insurance Committee

This Committee includes representatives of property casualty insurance companies who monitor the activities of the Mass Claims Commission and other CPR initiatives that have implications for the insurance industry. Given the impact of recent industry challenges, the Committee has been less active in the past year. The Co-Chairs of this Committee are Deborah Masucci of Chartis Inc. and Harold Moskowitz of Wilson, Elser, Moskowitz, Edelman & Dicker, LLP.

CPR has a pivotal role in empowering a global community of problemsolvers dedicated to ADR scholarship and advocacy. The mission of this group is to devise practical strategies to increase the participation of women and minorities in mediation, arbitration, and other ADR processes. Task Force members coordinate broadly with other groups, as well as speak and write, to raise awareness of diversity issues. In 2007, the Task Force developed "The ADR Diversity Survey" as a model for corporations seeking to measure the current state of participation of professional women and minorities in arbitration, mediation, and dispute settlement. In 2008, the Task Force established an annual "Award for Outstanding Contribution to Diversity in ADR" to recognize commitment to diversity in the field. The Co-Chairs of this Task Force are Tom Sager of E.I. du Pont de Nemours and Company, Charles Morgan of FTI Consulting, and Carla Herron of Shell Group.

Product Liability Committee

Picking up the work of a similar CPR corporate-led group from a decade ago, this Committee comprises representatives of manufacturers, claimants, insurers, and others aiming to study product liability litigation with the goal of generating a guide to the efficient and just resolution of such claims. The Committee has formed subgroups to study various aspects of the topic, and will invite other interested parties, such as indemnitors' and claimants' attorneys, to join them in their work. The Committee is currently developing a Protocol for Early Case Resolution of Product Liability Cases. The Chair of this Committee is Dale Matschullat of Newell Rubbermaid.

Task Force on Patent Mediation

CPR is currently forming a new Task Force to explore the benefits and barriers to effective use of mediation in patent disputes. The Task Force will build upon the work of CPR's previous International Commission on Patent Disputes and the Information Technology Conflict Management Committee, which published a Master Guide on Patent Mediation in 2006. In 2008, members of the Neutral Subcommittee of the Patent Commission met several times to evaluate the applications of candidates for the CPR's Technology Panel of Neutrals. The Chair of this Task Force is Manny Schecter of IBM Corporation.

Website

CPR's Special Projects

In July 2008, CPR launched a new website, featuring innovative social networking technologies. The website, at www.cpradr.org, acts as a single source for best practices, tools, and research in the area of alternative dispute resolution by providing access to CPR's rich archives of industry-specific contract clauses, rules, protocols, and procedures for the avoidance, management, and resolution of commercial conflict. CPR's intent was to create an online platform where its members, law firms, corporations, government entities, and the larger ADR community could engage in research and collaborate. This was accomplished through a number of enhancements, including customized RSS feeds, commenting and survey tools, content tagging, and blogs, videos, and podcasts. To announce the site to members, CPR produced a promotional video which highlighted the new features of the site and provided a link to encourage web registration.

Since the launch, nearly 2,000 people have registered on the website, and the site has had more than 60,000 unique visitors, representing a significant increase over the previous site. In the coming year, CPR will leverage the work of our members and committees by harvesting and posting user-generated industry-specific content of interest to ADR practitioners.

Heritage Dinner

CPR is particularly grateful for the integral role that our long-time members have played in helping us define best practices and spearhead innovation in the field of alternative dispute resolution. In January 2009, CPR honored members who have supported the organization for 20 years or more at the inaugural CPR Heritage Dinner. The elegant cocktail reception and dinner honored 100 member organizations and individuals whose contributions and

As our understanding of the benefits and limitations of different conflict management tools becomes more sophisticated, the search for effective problem-solving approaches continues to drive CPR's activities. support have helped CPR fulfill its educational mission for more than 30 years. Attendees included in-house counsel from Fortune 500 companies and senior attorneys representing law firms from around the world. In acknowledgement of their support, honorees were presented with personalized, signed, and numbered artwork by the 2007 Annual Report artist, Jon Berkley. CPR also acknowledged its Board Chairman, Hon. Charles Renfrew, and Vice-Chairman, Hon. William Webster, for their many years of service to the organization.

The Commission on Facilities for the Resolution of Mass Claims

Established in 2005, this group includes distinguished practitioners and experts with experience in resolution of mass claims, including judges, academics, and attorneys. It was convened to study the role of alternative dispute resolution methods in resolving mass claims and to promulgate best practices in the area. Recently, the Commission completed an outline of a book expected to debut in 2010. The book will review the use of ADR in various mass claims situations and recommend best practices for different types of mass claim situations, ranging from defective products causing property damage to September 11th-type tragedies.

Economical Litigation Agreements

In 2009, CPR assembled a group to explore Economical Litigation Agreements (ELA) as a means of reducing civil litigation costs. ELA is a hybrid of civil litigation and arbitration, where parties agree to model discovery procedures in lieu of conventional discovery. Currently in the testing phase, future model procedures may include concepts such as making the amount of discovery proportionate to the amount in controversy, phasing discovery to save time and reduce expenses in cases involving threshold motions, and creating cost-effective alternatives to conventional discovery. This group is chaired by Dan Winslow of Duane Morris LLP.

Other Projects

In addition to the projects and initiatives described above, CPR also participates in annual Mediation Settlement Day programs and provides educational and descriptive materials, at no charge, to universities, courts, and law associations, and to ADR organizations in less-developed countries. Fourteen law school and college interns worked at CPR during the fiscal year on a wide variety of important projects.

CPR is committed to communicating the best and most innovative dispute resolution ideas and theories from academic leadership to our membership of corporate counsel, attorneys, judges, and public sector leaders.

The 2008 Annual Meeting, held on January 17-18 at New York City's famed Waldorf-Astoria Hotel, welcomed more than 200 attendees and guests. The program was devoted to achieving long-term organizational change through integrated conflict management systems. Session highlights included a panel of corporate general counsel who discussed the challenges of enterprise-wide cultural change, a law firm panel who addressed how to help clients achieve efficiencies and economies in managing conflicts, and an analysis of system design and the corporate ethos. The Meeting featured keynote addresses by General Electric's Brackett B. Denniston III, Senior Vice President and General Counsel, and the Right Honourable Lord Woolf of Barnes, Former Lord Chief Justice of England and Wales.

Fourth Annual CPR European Congress

Vienna, Austria Theme: Business Dispute Management

Held in May 2008, CPR's European Congress convened a consortium of international business leaders and legal executives to address the art and practice of commercial conflict resolution around the world. Keynote presenters included Nestlé's Hans Peter Frick, who discussed "Fitting the Product to Satisfy the Customer," and Eric Green, considered a founder of modern mediation, who spoke about the numerous complexities of international mediation. International panelists presented on a number of ADR topics, including corporate social responsibility, overcoming impasse in tough negotiations, predispute ADR tools, and mediator accreditation.

2009 CPR Annual Meeting

New York, New York Theme: Innovations in Dispute Resolution: Lessons Learned and Predictions for the Future

The 2009 Annual Meeting was held in New York City on January 15-16 at the Barclay InterContinental Hotel. Marking CPR's 30th anniversary, the sold-out event welcomed more than 200 attendees and focused on the evolution of commercial conflict resolution over the past three decades. Keynote speakers were Professor Robert Mnookin, Chair of Harvard University's Program on Negotiation, who examined the evolution of commercial conflict resolution and explored what the future may hold for the field, and Kenneth Roth, Executive Director, Human Rights Watch, who stirred lively debate with his discussion of the synergies between human rights and dispute resolution, and the role that corporations play in ensuring that their overseas entities protect human rights. Panel sessions included an exploration of recent federal arbitration legislation, discussions related to mediator techniques and ethics, and a corporate scenario planning exercise. The meeting closed with predictions for the future of ADR, including the value of early case assessment and the increased role of technology.



Alternatives

Mattel* case, and followed it with extensive coverage of three additional ADR-related cases heard and decided by the Court during 2008-2009. They included a quantitative analysis of successful mediators' techniques, a guide to drafting international arbitration contract clauses, and a fiery multi-article debate on worldwide mediator accreditation trends. *Alternatives* also featured a comprehensive examination of state court systems' quick move to mediation in handling the mortgage foreclosure crisis. In spring 2008, *Alternatives* was recognized by the Specialized Information Publishers Association for its interpretation and analysis in its reporting of a Florida federal court mediation case involving Joe Francis, owner of the company that produces *Girls Gone Wild* videos and publications. Francis was jailed because of his mediation conduct.

Early Case Assessment

CPR assembled a Commission of corporate members and others to collaborate and produce Early Case Assessment Guidelines that can be used across a broad spectrum of disputes. These guidelines, released in May 2009, set forth a process designed to help businesses decide early on how to manage disputes, including identifying key business concerns, assessing risks and costs, and making an informed choice on handling the dispute. They also focus on evaluating the dispute so that an appropriate handling strategy can be formulated, whether

via settlement, litigation, or conflict resolution processes, with an eye toward reducing or eliminating disputes as quickly and as inexpensively as practicable. The Guidelines' tools consist of the ECA Executive Summary, Detailed Analysis, and Flow Chart.

New Publications

In January 2009, the Info Exchange Subcommittee of CPR's Arbitration Committee released *The CPR Protocol on Disclosure of Documents and Presentation of Witnesses in Commercial Arbitration.* The CPR Protocol addresses concerns often expressed by arbitration users by providing guidance in the form of recommendations that arbitrators may follow in administering proceedings before them, including matters conducted under the CPR Rules or under other ad hoc or institutional rules. The recommended practices deal with ways in which reasonable limitations may be placed on disclosure and efficiencies gained in the presentation of witness testimony in arbitration users and their counsel, the Protocol offers various "modes" of disclosure and presentation of witnesses, ranging from minimal to extensive, so that the parties to an agreement to arbitrate may choose, at the time of entering into their agreement or thereafter, the general way in which their arbitration proceedings will be conducted in the important areas of document disclosure and witness presentation.

Also in January, CPR published the *Drafting Dispute Resolution Clauses – 2008 Supplement.* Since the release of CPR's *Drafting Dispute Resolution Clauses* in 2006, numerous significant developments have occurred that are relevant to the drafting of dispute resolution clauses. The 2008 Supplement provides a readily accessible listing of the most recent important developments, new case law and helpful references in the field. The Supplement is keyed to the nomenclature and numbering of the 2006 publication.

In February 2009, CPR's Franchise Committee released *Managing Franchise Relationships Through Mediation.* This book is the next volume of the CPR Master Guide series and is a contribution by CPR and the Franchise Mediation Program toward assisting in creating a fair, just, impartial, and expeditious way of resolving disputes in the franchise community. In addition to providing franchise mediation procedures, the publication comprises case-study narratives from eight leading franchisees and franchisors. Each outlines how the process of mediation has been an effective tool for their business and the role that mediation has played in creating opportunities for successful dealings with stakeholders.

Y-ADR received an enthusiastic launch and reception in spring 2009. The purpose of the group is to engage practicing lawyers, 45 years old and younger, in the international ADR practice area. Corporate Leadership Award

Through the annual Corporate Leadership Award, CPR honors a company that has demonstrated leadership and commitment to the principles of conflict management and resolution and has institutionalized these principles into its corporate culture. Past honorees have included Johnson & Johnson, General Electric, Ernst & Young, and ConocoPhillips.

The 2008 honorees were Microsoft and its Senior Vice President, General Counsel and Corporate Secretary Brad Smith. Microsoft is a pioneer in the corporate legal community's commitment to conflict resolution practices and principles. Under Brad Smith's leadership, the company has used alternative dispute resolution in a variety of litigation matters, in addition to using preventive measures. The review committee acknowledged Herbert Smith for having demonstrated firm-wide commitment to using ADR principles and techniques; educating the legal market about mediation and ADR; and setting the benchmark for addressing the resolution, prevention, and creative management of disputes through their development of an innovative ADR Toolkit shaped by the firm's in-house research into corporate ADR use.

Honorable Mention was awarded to international law firm Eversheds for its continued commitment to ADR education and for the evolution of the firm's RAPID Resolution program.

Award for Outstanding Contribution to Diversity in ADR

At its 2009 Annual Meeting, CPR presented the organization's inaugural "Award for Outstanding Contribution to Diversity in Alternative Dispute Resolution" to Marvin E. Johnson. CPR's National Task Force on Diversity created the award to recognize a person who has contributed significantly to diversity in the field of ADR by providing access to or creating opportunities for people who have historically been excluded from active and meaningful participation including, but not limited to, women, minorities and/or people of color.

Paramount among his many achievements is Johnson's founding of the Center for Alternative Dispute Resolution. Focusing primarily on practical application of ADR principles, the Center aims to promote and provide education and comprehensive approaches to dispute resolution that constructively serve the needs of a culturally diverse society.

James F. Henry Award

CPR awarded its 2008 James F. Henry Award to the Right Honourable Lord Woolf of Barnes, the former Lord Chief Justice of England and Wales. Named for CPR's founder, the award recognizes individuals for their commitment to the principles of ADR and for outstanding achievement and contributions to the field of commercial conflict resolution. Previous winners of the Award include Senator George J. Mitchell and Hon. Janet Reno.

Lord Woolf is one of the most well known and respected English judges of our time. Amongst his most notable achievements, he conducted an extensive inquiry into the Civil Justice system in England and Wales between 1994 and 1996. This inquiry led to the most significant reform of the British Civil Justice system during the past 50 years.

CPR Annual Awards Program

Each year, CPR promotes excellence in scholarship and practical achievement through its Awards Program.

In 2008, CPR Awards were presented to:

CPR Around the World

CPR's core constituents are becoming increasingly global in their operations. In response, the organization has dedicated significant resources to extending its reach across industries and geographic areas to become an international leader in promoting innovation in commercial dispute resolution. With the assistance, support, and guidance of its leading global members, CPR has undertaken a multi-branched initiative to promote commercial mediation and other methods of consensual conflict management in regions outside the U.S. As globalization becomes an integral component of business decision making, CPR remains focused on instilling an enduring commitment to dispute prevention, management, and resolution among businesses, institutions, and citizens around the world. CPR leads the way by providing expertise and insight to expand ADR use across borders and cultures.

Focus on Europe

The past decade has been an exciting period for ADR in Europe. As the field has matured, CPR has expanded its activities to better address the use and application of ADR processes outside of the U.S. This year, through committee convening efforts, numerous international speaking engagements, and CPR's European Congress, CPR has devoted significant resources to promote the art and practice of commercial conflict resolution around the globe. However, more work is needed to define and establish a European platform and direction for CPR's future initiatives. In the coming year, CPR will assemble focus groups of corporate users to identify where it can most add value in Europe. It will also explore alliances with other international organizations to assist CPR in expanding its impact throughout the region.

Asia Initiative

In 2009, CPR made visits to various arbitral institutions in China, as well as CPR member law firms in both China and Vietnam. Visits included the Arbitration Center and CCPIT in Beijing and the American Chamber of Commerce in Shanghai to discuss various ways in which these institutions and CPR might work together to facilitate knowledge and training in the ADR field. While in Hanoi and Ho Chi Minh City, CPR met with law firm representatives, as well as members of the judiciary, to exchange information and to explore how CPR might play a role in Vietnam with respect to the promulgation of information about ADR and potential training programs.

In partnership with its international members, CPR continues to explore and develop resources for managing crossborder, cross-cultural conflict.





Financials


In these turbulent economic times, fundraising has been challenging for all nonprofit organizations. As a result, CPR has focused on ways to diversify its revenue sources and creatively safeguard operations. These proactive efforts have preserved its ability to deliver on its mission with more than 70% of CPR's expenses directly supporting programs and services.

In FY09, CPR's balance sheet was strengthened with more than \$200K in net assets. Specifically, contributions and grants increased from 5% in 2007 to 17% in 2009. The most significant contributors to this increase are major gifts from CPR's Platinum Sponsors, General Electric Company and Howrey LLP, and a significant in-kind donation from Huron Consulting. CPR's 2008 Corporate Leadership Award Dinner represented a significant source of contributions at 19% of total revenue. Other program activities, such as Dispute Resolution Services, Training, Meetings, and Publications, accounted for 24% of total revenues in FY09.
